# Terms and conditions of the promotion SUNSHINE SALE



## Terms and contitions

### § 1 General provisions

1. The Organizer of the Promotion Action called "Sunshine sale", hereinafter referred to as the "Promotion" is the network of Medicover Optyk (Medicover Optician) optical showrooms with their registered office in Warsaw at Al. Jerozolimskie 96, hereinafter referred to as "Medicover Optician".

#### § 2 Promotion rules

- 1. The promotion begins on 14 May 2018 and closes on 30 June 2018.
- 2. After the end of the Promotion, the offer described below is not applicable.
- 3. All patients are Participants of the Promotion, hereinafter referred to as the "Participant(s)". The patients over 16 years of age only are invited to undergo the examination of their vision. The patients under 18 years of age are invited to the examination of their vision if accompanied by their legal guardian.
- 1. Terms and conditions of the promotion:
  - a) the Participant may purchase sunglasses at a reduced price with a 40% discount;
  - b) the Participant may purchase coloured corrective lenses at a reduced price with a 30% discount. The promotion does not apply to spectacle frames;
  - c) the Participant may purchase photochromic lenses (Transitions) at a reduced price with a 30% discount. The promotion does not apply to spectacle frames. The discount for lenses the promotion does not include progressive lenses.
- 4. The Participant shall be entitled to the discounts specified in points (b) and (c) on the basis of a current document confirming a visual impairment (such as a spectacle prescription) issued during the period of the Promotion as specified in points (c) and (d) above of section 1. A prescription for lenses may be issued by a doctor of Medicover Centre, Medicover Optician or another institution.
- 5. There is a possibility to make glasses according to a prescription issued earlier than the date of the beginning of the Promotion or on the basis of current glasses and benefitting from the proposed discounts this is possible on condition that the patient shall accept the full responsibility for the quality of vision when using such glasses.
- 6. The Participant may use the Promotion for a number of times in the period of the Promotion being effective.
- 7. The discounts within the Promotion do not add up to the discounts for care services at Medicover or other promotional programmes.

## § 3 Medicover Optician facilities

1. The promotion is valid at Medicover Optician showrooms in Warsaw and Wrocław. The list of showrooms is available at the website.

## § 4 Complaint conditions

- 1. The Participant has the right to raise objections concerning the quality of vision in the spectacles prepared within the Promotion not later than within three (3) months from the date of the eye examination at Medicover Optician
- 2. If the Participant decides to order the spectacles on the basis of a prescription issued before the start of the Promotion, the quality of vision in spectacles manufactured as part of the Promotion shall not be subject to



complaints unless the impaired quality of vision in spectacles is the result of a technical defect in the spectacles or their incorrect assembly.

- 3. In addition, Medicover Optician provides a guarantee to grant a 50% discount on the purchase of new spectacles in the event of the mechanical damage to spectacles purchased as part of the Promotion, resulting from the obvious fault of the Participant and rejected by the manufacturer of the spectacles.
  - 1. The warranty is valid for up to one year (365 days) from the date of purchase of the glasses that have been damaged.
  - 2. The discount shall cover the purchase of the same lenses and the same frame as the ones that have been damaged.
  - 3. If the frame is no longer available from the manufacturer, it is possible to choose another one at the same price as the damaged one.
  - 4. If the Participant chooses a more expensive frame than the damaged one, the maximum discount the Participant can get for its purchase is 50% of the value of the damaged holder.
  - 5. If the Participant chooses a less expensive frame than the damaged one, the maximum discount the Participant can get for its purchase is 50% of the value of the newly selected frame.

## § 5 Final provisions

- 1. Medicover Optician has the right to make changes to the terms and conditions at all times without specifying any reason by informing the Participants in the form of a publication on the Medicover website at <u>www.medicover.pl</u>.
- 2. Any changes in the terms and conditions and closing the Promotion shall not affect the rights acquired by the Participants until the end of the Promotion.
