Terms and Conditions of the Promotion "Branded frames for PLN 1"



§ 1 General provisions

1. The "Branded frames for PLN 1" Promotional Campaign, hereinafter referred to as the "Promotion," is organised by Medicover Sp. z o.o., with its registered office in Warsaw, Al. Jerozolimskie 1, entered into the National Court Register under number KRS 0000021314, operating the chain of optical Medicover Optician showrooms, hereinafter referred to as "Medicover Optician."

§ 2 Rules of the Promotion

- 1. The Promotion starts on 1 October 2023 and continues until further notice.
- 2. Once cancelled, the Promotion ceases to apply.
- 3. The participants of the Promotion, hereinafter referred to as the "Participants," are all natural persons who make the purchase referred to in point 4 below during the term of the Promotion.
- 4. Terms of the Promotion:
 - a. A Participant of the Promotion, who purchases corrective glasses (i.e. optical frame + corrective lenses) is entitled to purchase the second optical frame for PLN 1. In order to benefit from the Promotion, it is necessary to purchase corrective lenses, which are not subject to a discount, for the second optical frame. Powers of the lenses for the first and second optical frames may differ, which means that second corrective glasses may be purchased for another Participant of the Promotion.
 - b. The Promotion is not applicable to the purchase of SMILE and Maxxee economical corrective lenses and lenses with Trio, Trio Clean, Crizal Easy, HARD or HVA coating in both glasses.
 - c. In order to benefit from the Promotion, it is necessary to purchase the second corrective glasses no later than on the day of collecting the first order in the Medicover Optician showroom.
 - d. The sale price of the second optical frame must be equal to or lower than the price of the first frame. If the price of the second frame is higher, the Participant shall cover the price difference.
 - e. The Promotion applies to all models of optical frames, except for luxury frame brand, such as Dior, Loewe and Celine, in the second glasses.
 - f. In order to benefit from the Promotion, the Participant shall join the free loyalty programme MediClub by registering at www.optyk.mediclub.pl, or provide an email address (for which an account has been created via www.optyk.mediclub.pl) to an employee of a showroom. The email address will be used to verify whether a given Participant is registered in the MediClub base.
 - g. The Promotion applies only to the purchase of optical frames. It does not apply to the purchase of sunglasses, corrective lenses, contact lenses and accessories.
 - h. The Promotion applies to the product range, i.e. optical frames, available at a showroom.
- 5. Medicover Optician provides an additional guarantee against mechanical damage, loss or theft of glasses during the first year of use. Details of the guarantee are set out in a separate document "Medicover Optician Guarantee," available at the Medicover Optician showrooms.
- 6. During the term of the Promotion, the Participants are entitled to use it more than once.
- 7. In the case of the Medicover Optician Outlet Żelazna showroom in Katowice, the Promotion applies only to the showroom's standard offer, understood as optical frames and sunglasses from current collections. The Promotion does not combine with the Outlet part of the showroom's offer, the terms and conditions of which are governed by a separate document, available at the showroom.
- 6. The patients who are not covered by medical care at Medicover and would like to make a purchase under the Promotion are entitled to a free eye examination at Medicover Optician.
- 7. The Participant can benefit from currently applicable promotion with respect to the purchase of the first corrective glasses.
- 8. The Promotion can be combined with the Tandem Offer, the rules of which are set forth in a separate document.
- 9. The Promotion cannot be combined with the Multipair and Multipair in 90 days promotion.
